

2023 NRCA Constructing Excellence Awards

The 2023 NRCA Awards are open to all NRCA Industry Members in good standing. Nominees must have been NRCA Members for a minimum of three (3) months at time of submission. Submissions for the NRCA Awards can be self-nominated or independently nominated.

Submission requirements:

1. Completion of the application form
 - All applications are anonymous and can be self or peer nominated.
 - Approx. 500-word description of why the nominated company or individual is worthy of the award.

Please refer to nomination forms for additional mandatory requirements that are unique to each Award.

SAFETY EXCELLENCE AWARDS (3)

The Safety Awards are designed to honour those contractors who have maintained a superior safety record during the year. The Safety Award will be based on a contractor's claims experience record with the Workers' Compensation Board. Three companies will be selected for this award.

Mandatory submission requirements:

1. Completion of the application form
 - All applications are anonymous and can be self or peer nominated.

- Submissions for this award require access to the company's safety rating via WorkSafeBC. The number can be given at different times, either phone or by email by the nominee or included on the application.
- Approx. 500-word description of why the nominated company is worthy of the award.

JUDGING PROCESS

A panel of judges will review and score all submissions against the prescribed criteria. The judges reserve the right to re-assign entries to the category they deem fit.

The judging panel is made up of 3-4 unbiased, third-party construction and/or business professionals.

AWARD CONDITIONS

- The Chair of the NRCA Board of Directors is not eligible during the year in which they hold such a position.
- The decision of the Awards Committee is final and not subject to appeal.
- If the entry contains any feature that is, or could be, protected by patent rights the submission must be accompanied by written evidence demonstrating that the necessary steps have been taken to secure the requisite legal protection; neither the sponsor of the NRCA Award nor the Northern Regional Construction Association (NRCA) can assume any responsibility for "prior disclosure" in advance of a patent application.
- All submissions in support of a Nominee for the NRCA Awards become the property of NRCA.
- All photographs submitted with NRCA Award nominations also become the property of NRCA. These will be used to promote the NRCA Awards, the Association, and the construction industry.
- Submissions timestamped after the submission deadline will not be considered.

NOMINATION SUBMISSION DEADLINE

NRCA Award nomination submissions **must be received before 12:00 PM, January 15th, 2024 (PDT).**
